**Stingrays Club Owned Equipment**

The following compulsory football equipment is issued on loan by the club free of charge. Players who do not own their own approved helmet or shoulder pads can also hire this equipment from the club. The cost to hire the equipment is for the entire season. If a player buys a helmet and/or shoulder pads part of the way through the season and no longer requires the hired equipment, no refund will be available. All equipment must be cleaned and sanitised immediately after every training session and every game. All equipment listed below, where issued to a player, remains the property of the club. Equipment is to be returned as directed by club officials in the same condition as it was provided (allowing for fair wear and tear). Alterations to club equipment are not permitted. Failure to comply with any of the above will result in the following replacement costs being immediately payable by the player to the club, for each item of equipment affected.
